BID PRICES WILL BE F.O.B. TO THE NORTHEAST MISSISSIPPI REGIONAL WATER TREATMENT PLANT, 5590 HWY 178 WEST, FULTON, MS 38843. THE NORTHEAST MISSISSIPPI REGIONAL WATER SUPPLY DISTRICT RESERVES THE RIGHT TO ACCEPT ALTERNATE BIDS IN THE EVENT THE PRIMARY SUPPLIER IS UNABLE TO PROVIDE PRODUCT AS SPECIFIED.

LIME MUST BE ANSI/NSF STANDARD 60 APPROVED. ALL VENDORS SHALL PROVIDE CERTIFICATE OF ANSI/NSF STANDARD 60 APPROVALS. THIS SHALL BE SUBMITTED WITH YOUR BID. THE BID SHALL BE ON A BULK BASIS AND MATERIAL SHALL MEET THE FOLLOWING SPECIFICATIONS:

1. **LIME (BULK)**

Available lime index 2.0%

Available calcium hydroxide - 95.93%

CaCO₃ - 0.61%

Magnesium oxide - 3.0%

90% of material should pass 325 water insolubles retained on mess will be less than 0.8%.

Delivery shall be within 5 days of notification of the order.

SIZE OF ORDERS WILL BE BASED ON AVAILABLE STORAGE AT THE PLANT. **ALL PRICES SHALL BE FOR BULK QUANTITIES AND SAID PRICES SHALL REMAIN CONSTANT FOR A PERIOD OF THREE CALENDAR MONTHS, APRIL 1ST, 2023 THRU JUNE 30TH, 2023, FOLLOWING THE ACCEPTANCE OF THE BIDS.
