

## ADVERTISEMENT FOR BIDS

Separate sealed bids for the construction of SEWER SYSTEM REHABILITATION, TOWN OF HICKORY FLAT, MS will be received by the Town of Hickory Flat, Mississippi at the Town Hall Building located at 225 Spruce Street, Hickory Flat, MS 38633, (mailing address: P.O. Box 479, Hickory Flat, MS 38633), Attn: Brandy Huey, until **10:00 a.m., Thursday, September 2<sup>nd</sup>, 2021** and then at said office publicly opened and read aloud.

Contract Documents, including Drawings and Specifications, can be viewed and/or purchased at Ward Engineering, Inc. plan room at [www.wardengplans.com](http://www.wardengplans.com). All plan holders are required to have a valid email address for registration. Bid documents are non-refundable and must be purchased through the website. This project is available for electronic bid submittals. Should a bidder choose to submit a bid electronically in place of a sealed bid, it may be submitted at [www.wardengplans.com](http://www.wardengplans.com). The work shall consist of: **SEWER SYSTEM REHABILITATION.**

Each bid submitted must be in a sealed envelope addressed to the Town of Hickory Flat, and clearly marked on the outside "**Bid for: SEWER SYSTEM REHABILITATION, Town of Hickory Flat, MS, CDBG PROJECT #1134-20-211-PF-01**". Any bid in excess of \$50,000 must contain on the outside of the envelope the contractor's current certificate of responsibility number, and no bid shall be opened or considered unless this number appears on the outside of the envelope or unless a statement is included on the outside of the envelope indicating that the bid enclosed does not exceed \$50,000.

When bidders chose to submit bids electronically, the requirement for including a certificate of responsibility, or a statement that the bid enclosed does not exceed Fifty Thousand Dollars (\$50,000.00), on the exterior of the bid envelope shall be deemed in compliance by including the same information as an attachment with the electronic bid submittal. The Bidder is fully responsible for on time delivery of bids regardless of bid submittal method chosen.

A satisfactory Bid Bond executed by the Bidder or an accepted Surety, a certified check, or bank draft payable to the TOWN OF HICKORY FLAT, MISSISSIPPI, on negotiable U.S. Government Bonds (at par value), shall be submitted with each bid in an amount equal to five percent (5%) of the total bid.

Bidders are directed to the contract requirement that not less than the minimum wages and salaries set forth in the Contract Documents must be paid on this project, in accordance with the Davis-Bacon and Related Acts. In addition, the Contractor must ensure that employment and applicants for employment are not discriminated against because of their race, color, religion, sex or natural origin.

Bids may be held up to 90 days from the date of opening for review of bids and qualifications of bidders prior to Contract award. The TOWN OF HICKORY FLAT, MISSISSIPPI reserves the right to reject any or all bids or to waive any informality in the bidding.

This project is being funded in part by a Community Development Block Grant (CDBG) and is subject to the rules and regulations thereof and is subject to the requirements of Section 3 of the Housing and Urban Development (HUD) Act of 1968, as amended.
