The project consists of removing and replacing (80) eighty 35 ft. long class B timber piles, installing (4) four new 35 ft. long class B timber piles at the north end of the "Kensington" Harbor, and relocating the fish cleaning station to the north end of the "Kensington" Harbor. "Kensington" Harbor will be dredged +/- two feet in depth and twenty feet from the dock. 1481 CY of material is expected to be removed.
