Sealed bids for the construction of the Elevated Tank Rehabilitation CDBG Project No. 1133-17-195-PF-01 for the Town of Gloster in Gloster, Mississippi, will be received by The Honorable Jerry Norwood, Mayor of the Town of Gloster, Mississippi, until 11:00 AM local time on Tuesday, January 30, 2018, at the Town Hall located at 251 S First Street., Gloster, MS 39638, and shortly thereafter will be opened and publicly read.

The work involved in the project includes the rehabilitation of an existing 50,000 Gallon (hemispherical bottom, riveted steel) Elevated Water Storage Tank – (interior/exterior) with contaminant shrouding and other incidental items as described in the project Construction Drawings and Contract Documents. A non-refundable deposit of \$100.00 is required at the time of request for Construction Drawings and Contract Documents. A pre-bid conference for this project will be held at Gloster Town Hall located at 251 S First Street, Gloster, MS 39638, on Tuesday, January 16, 2018, at 11:00 A.M. Attendance is strongly encouraged but is not mandatory.

This construction project is financed by the Mississippi Development Authority, Community Services Division, by a Community Development Block Grant through the Small Government Public Facilities Category, 1133-17-195-PF-01, and is subject to the rules and regulations of the Housing and Community Development Act of 1974 and all amendments thereof. Neither the United States nor any departments, agencies, or employees is, or will be, a part of this Invitation for Proposals or any resulting contract.

The work to be performed under this contract is subject to the requirements of Section 3 of the Housing and Urban Development Act of 1968, as amended. CDBG regulations governing the grant require that, to the greatest extent feasible, opportunities for contracting, subcontracting, training, and employment arising in connection with this CDBG project will be extended to Section 3 businesses and Section 3 residents.

Davis Bacon Act: The Contractor shall pay labor rates set forth by “wage rates” as mandated by the U.S. Department of Labor.

Minority and women’s business enterprises are solicited to bid on this contract as prime contractors and are encouraged to make inquiries regarding potential subcontracting opportunities, equipment, material and/or supply needs.

The Town of Gloster is an Equal Opportunity Employer.
