The Project includes the following Work:

Demolition, 8" solenoid valve installation, water well modifications, water treatment plant, 6" and 8" raw water main installation, and electrical/control improvements.

Owner anticipates that the Project's total bid price will be approximately \$1,500,000. The Project has an expected duration of 270 days.
