- D. Bidders will be required to provide Bid security in the form of a Bid Bond in the amount of 5% of the Base Bid.
 - 1. Bid Bond must be submitted to the office of the Desoto County Board of Supervisors prior to the time of the Bid Due Date.
- E. Refer to other bidding requirements described in Document 00 2113 - Instructions to Bidders and Document 00 3100 - Available Project Information.

- F. Submit your offer on the Bid Form provided. Bidders may supplement this form as appropriate, and as allowed by the State of Mississippi Public Bid Laws.
- G. Submit your Bid in Duplicate for hand-delivered bid packages.

- I. Your offer will be required to be submitted under a condition of irrevocability for a period of 30 (thirty) calendar days after submission.

All bids submitted in excess of \$50,000 by a prime or subcontractor to do any erection, building, construction, repair, maintenance or related work must comply with the Mississippi Contractors Act of 1985 by securing a Certificate of Responsibility from the State Board of Contractors. The Prime Bidder's Certificate Number must be placed on the outside of the sealed envelope or the bid will not be opened. Electronically submitted bid packages must have the Certificate Number listed on the Bid Form. Subcontractors requiring a Certificate of Responsibility must be listed, including their Certificate of Responsibility Number, on the Sub-Contractor List with the Bid.
