#### GENERAL

No bids may be withdrawn for a period of forty-five (45) days following the scheduled opening date.

The Board of Trustees reserves the right to reject any and all bids and waive any informalities.

Vendor must be licensed to do business in the State of Mississippi.

Must be in compliance with all federal, state and local laws.

ALL items MUST be Asbestos free.

Certificate of responsibility is required for bids of \$50,000 or more. Follow State of Mississippi laws.

#### **SEALED BIDS**

The South Panola School District (SPSD), Batesville, Mississippi, will receive sealed bids at the Central Office Administration Building until **April 10, 2018 at 9:00 a.m. (CST).**All bids shall be submitted to this address on or before the above time and date. All bids items are to be based on **delivery F.O.B.** Any restrictions or conditions which would affect delivery or purchase of a single or any quantity of item(s) shall be written by the bidder and attached to the bid when submitted.

The vendor shall be required to maintain or to have available for his own use an inventory sufficient to make shipment within the time stated in the bid. Maximum delivery is ten (10) days after receipt of order (ARO) for categories 5, 6 and 7. Total orders shall be delivered within ten (10) days ARO. If the vendor cannot deliver the total order within this time frame, the vendor shall fax or email the school district the reason they cannot deliver all items within the ten (10) days.

#### **PRICE**

Cost must be shown on the attached Bid Sheet. All bids must be **FIRM PRICE.** Price must include all taxes. South Panola School District will furnish tax-exemption certificates for State and Federal taxes where applicable.

SPSD will hold the successful bidder responsible for any damage caused to the building or assets of the SPSD under all conditions.
