1.1 Statement of Purpose

Jackson State University (JSU) is seeking to purchase end user Apple computing hardware (such as desktop, laptop, and workstation computers) for the Art department. JSU intends to enter into a new agreement with one entity for the purchase of Apple computing hardware and equipment.

1.2 Background Information

Jackson State University is a 4-year Carnegie High Research Public University located in Jackson, MS. The University is accredited by the Commission on Colleges of the Southern Association of Colleges and Schools to award Bachelors, Masters, Education Specialist, Doctor of Education, and Doctor of Philosophy degrees. 1.3 Scope of Work

Outcome and Performance Standards

Jackson State University expects to receive pricing proposal for the Apple equipment listed in the Scope of Work section 1.3.

1.5 Deliverables

Anticipated implementation is **TBD**. If Vendor is unable to meet this timeframe, the Vendor <u>must</u> describe the best possible delivery schedule. The delivery schedule will be scored based on the Vendor's ability to meet the anticipated implementation as closely as possible.

1.6 Term of Contract

Freight: All deliveries shall be freight prepaid, F.O.B. destination and shall be included in all pricing offered unless otherwise clearly stated in writing.

Warranty Conditions: All equipment and services shall include manufacturer's minimum standard warranty unless otherwise agreed to in writing. Vendor shall be an authorized dealer, distributor or manufacturer for all products. All equipment proposed shall be new and not priced or labeled as pre-owned, reconditioned or retired. It should be clearly labeled in the proposal if the equipment is not new.

1.7 Payments and Penalties

Jackson State University will make payments directly to the Vendor or vendor assigned dealer at net 45 days after receiving invoice.

1.8 Contractual Terms and Conditions

JSU's general terms and conditions will be included by Purchasing. However, it is the department's responsibility to check with Risk Management and Safety for any applicable insurance requirements and Office of IT for any applicable data security requirements.

1.9 Requirements for Proposal Preparation

Jackson State University acknowledges that the specifications within this RFP are not exhaustive. Rather, they reflect the known requirements that must be met by the proposed system. Vendors **must** specify, here, what additional components may be needed and are proposed in order to complete each configuration.

1.10 Evaluation and Award Process

The University shall determine the award after evaluating each response on the following points. For the basis of award, each of the points will be considered in the listed order:

Financial Considerations: 50%

Customer Service & Technical Support: 20%

Technical Capabilities & Requirements: 15%

Equipment Delivery Timeframe and Schedule: 15%
