PLANS AND SPECIFICATIONS are on file in the Office of the Chancery Clerk of Alcorn County, the County Engineer's office and the Office of the State Aid Engineer, 412 E. Woodrow Wilson Avenue, Jackson, Mississippi. This project shall be constructed in accordance with the latest edition of the Mississippi Standard Specifications for State Aid Road and Bridge Construction.

PLANS AND PROPOSALS may be secured from Kenneth P. Geno, Jr., County Engineer for Alcorn County at www.cceplanroom.com. The Cost is fifty dollars (\$50.00) for plans and fifty dollars (\$50.00) for the proposal, non-refundable. Certified check or bid bond for five percent (5%) of the total bid, made payable to Alcorn County and the State of Mississippi must accompany each proposal. For Bidders submitting bids electronically, the bond submitted must be either a bond issued by the Surety in electronic format or the original hard copy of the bid bond must be submitted to the Alcorn County Board of Supervisors, 305 South Fulton Drive, Corinth, Mississippi prior to bid opening in order for the bid to be valid.

The entire PROPOSAL is required to be turned in for both paper and electronic bid submission.

Bids will be accepted only under the name of the Bidder to whom PLANS AND PROPOSALS have been issued by the County Engineer, and whose name appears on the official list of Planholders maintained by the County Engineer.

Bidders are hereby notified that any proposal accompanied by letters qualifying in any manner the condition under which the proposal is tendered will be considered an irregular bid and such proposal will not be considered in making the award.
