Meals must be nutritious, well balanced, tasty meals, served three (3) times a day, seven days a week. Under Section 19-25-73 of the Mississippi Code. Bid price should be stated at price per meal based on one (1) or more prisoners per day. Feeding times to be arranged with Sheriff's Office. Two (2) hot meals each day and one (1) cold meal each day. Meals will be prepared on site by bidder in Sheriff's Department Kitchen, County will provide kitchen and will serve meals only. The Board will pay for said meals on a monthly billing.

The Board of Supervisors reserves the right to reject any and all bids. Contract will be awarded on the basis of lowest and best bid.

If the Amite County Courthouse/Board of Supervisors is closed for any reason, including but not limited to: acts of God, strikes, lockouts, riots, acts of war, epidemics, governmental regulations superimposed after the fact, fire, earthquakes, floods or other natural disasters (the "Force Majeure Events"), which closure prevents the opening of bids at the advertised date and time, all bids received shall be publicly opened and aloud on the next business day that the Amite County Courthouse/Board of Supervisors shall be open and at the previously advertised time. The new date and time of the bid opening, as determined in accordance with this paragraph, shall not be advertised, and all Vendors/Contractors, upon submission of a bid proposal, shall be deemed to have knowledge of and shall have agreed to the provisions of this paragraph. Bids shall be received by the agency until the new date and time of the bid opening as set forth herein. Contract Term shall be January 2020 or upon award by the Amite County Board of Supervisors, whichever is later, through December 2020, subject to extension and termination provisions.

Amite County reserves the right to extend any or all contracts for (4) additional 12-month periods, up to 60 months as allowed by law, based on contractor/supplier performance, cost savings, product quality and other factors.

Due to fluctuations in the prices of materials used in the requested products, price adjustments may be considered each year during renewal negotiation. Any price adjustments, increases or decreases, shall be based upon publicly known factors such as the producer's price index (PPI), the consumer price index (CPI), the minimum wage law or other agreed upon price factors and shall be approved by the Amite County Board of Supervisors.

Such extensions will be subject to approval of the Amite County Board of Supervisors and mutual agreement of contract holders, and shall be granted only at the established prices (subject to adjustments) and terms of the original contract on file.

Amite County reserves the right to terminate the contracts with 30 calendar days written notice, at its discretion, based on the same factors.
