

ADVERTISEMENT FOR BIDS

Separate and sealed bids for the construction of **WASTEWATER FACILITIES IMPROVEMENTS – CONTRACT 1 REBID** and **ARC WWDF – SEWER SYSTEM IMPROVEMENTS – CONTRACT 2** will be received by the **TOWN OF MANTACHIE**, located at **MANTACHIE TOWN HALL, 3256 HWY 371 NORTH, MANTACHIE, MS 38855** until **4:00 PM, THURSDAY, THE 16TH DAY OF APRIL, 2020** and then at said office publicly opened and read aloud.

The **WASTEWATER FACILITIES IMPROVEMENTS – CONTRACT 1 REBID** project consists of the following approximate items:

- Three (3) Pump Station Renovations
- 280' of Elevated Gravity Sewer Line Replacement at Three (3) Creek Crossings
- 890' of 8" HDPE Pressure Sewer Line @ Mantachie Creek
- One (1) Manhole Rehabilitation

The **ARC WWDF – SEWER SYSTEM IMPROVEMENTS – CONTRACT 2** project consists of constructing an approximately 10.4 acre bentonite sealed lagoon, triplex pumping station, and piping.

The non-refundable cost of each set of the Bid Documents is \$150.00 (Note: Contract 1 and Contract 2 are independent projects, therefore documents must be purchased and bid individually as such). All payments for Bid Documents shall be made payable to Plan House Printing and Graphics, 607 West Main Street, Tupelo, MS 38804.

Bids will be accepted only under the name of the Bidder to whom contract documents have been issued by Plan House Printing, on behalf of the Engineer, and whose name appears on each set of the official lists of Planholders maintained by Plan House Printing.

Minority and women's business enterprises are solicited to bid on this contract as prime contractors and are encouraged to make inquiries regarding potential subcontracting opportunities, equipment, materials and/or supply needs. The **TOWN OF MANTACHIE** is an Equal Opportunity Employer. The **TOWN OF MANTACHIE** hereby notifies all bidders that it will affirmatively insure that in contracts entered into pursuant to this advertisement will be

afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, sex, national origin, age, disability, sexual preference, marital or veteran status or any other legally protected status in consideration for an award.

The successful bidders must comply with the Davis-Bacon Act which requires that all laborers and mechanics shall be paid at rates not less than those determined by the Department of Labor to be the prevailing for the locality in which the project is located.

This project is being funded in part by the Appalachian Regional Commission (ARC) Grant **#MS-19556** and the rules and regulations therein apply.

The contracts will be awarded as an entire job and individual items will not be let for separate work.

Each bidder must deposit with this bid, security in the amount, form and subject to the conditions provided in the Information for Bidders.

No Bidder may withdraw his bid within 90 days after the actual date of the opening thereof.

Simultaneously with his delivery of the executed contract, the Contractor shall furnish surety bonds subject to the conditions provided in the Information for Bidders.

All applicable laws, ordinances and the rules and regulations of all authorities having jurisdiction over construction of the project shall apply to the contract throughout.

Each Bidder is responsible for inspecting the site and for reading and being thoroughly familiar with the Contract Documents. The failure or omission of any Bidder to do any of the foregoing shall in no way relieve any Bidder from any obligation in respect to this Bid.

A conditional or qualified Bid will not be accepted. Awards will be made to the lowest responsible, responsive Bidder for each contract.

The Owner reserves the right to waive any informalities or to reject any or all Bids.
