Project includes the arena grid system as indicated on the Drawings and specified herein. The work includes, but is not limited to, a new suspended aluminum truss system supported by the main roof framing; suspended maintenance and fall protection equipment; catwalks that will connect new truss system to existing structure; structure demolition of existing show rigging hangars; and relocation of existing electrical lighting.

Bids shall be received, sealed and marked: "Arena Grid System" on the envelope not later than **3:00PM on May 23, 2019** at 2350 Beach Boulevard, Biloxi, MS 39531 at which time said Bids will be opened, read out loud, and recorded. On the outside of the bid envelope, Contractor's Certificate of Responsibility number must appear. Any Bids received after said date and time shall be returned to the Bidder unopened.
