Bidding will be held by reverse auction at **12:00 P.M. Thursday, March 19, 2020**. The committee reserves the right to utilize "anti sniping" for reverse auctions. Anti-sniping is a tool that automatically extends the bid time for a reverse auction by five (5) minutes if a vendor places a bid in the final five (5) minutes of the reverse auction. The anti-sniping effect will auto extend the reverse auction bid time any time a bid is placed in the last five (5) minutes of the reverse auction and can auto extend the reverse auction multiple times until the bidding on the reverse auction ends.

Winning bidder will be notified by either phone or email. Non-winning bidders will not be contacted.

The bidder shall obey all Federal, State, County, or City laws and ordinances in any way pertaining to the work and shall obtain all permits that may be necessary for its performance if required. (a) That in the hiring of employees for the performance of such contract, nor any person acting on behalf of such bidder or shall by reason of race, creed or color discriminate against any citizen of the United States who is qualified and able to perform the work (b) Nor shall they in any manner discriminate against or intimidate any employees hired for the performance of the work on account of race, creed or color.

The Bidder shall be responsible for and agrees to indemnify and hold harmless NEMCC from all losses, damages, expenses, claims, demands, suits and actions brought by any party against NEMCC as a result of the Bidder's failure to comply with the provisions above.
