Geodetic control is required for examining mapping accuracies of a variety of experimental instrumentation deployed on unmanned environmental monitoring systems. This work will be conducted in Hancock, Harrison, and Jackson counties, Mississippi and in Mississippi Sound.

The selected engineer shall complete engineering services in accordance with applicable State and Federal laws, regulations, and procedures. Engineer will serve as the Owner's professional engineering representative for the Project and will provide professional engineering consultation and advice.
