1. Describe the commodity/service that the agency/institution is seeking to procure:

CHADIS is an IT platform that would allow providers to access to over 400 questionnaires/screeners for patients. It also provides a system of communication between patients and healthcare providers. As part of the practice transformation initiative with our grant, the licenses would be purchased for participating physicians and residents

2. Explain why the commodity/service is the only one (1) that can meet the needs of the agency/institution:

CHADIS would enable providers to streamline the process of screening children for behavioral and developmental delays. The tools are available in English, Spanish, and French with results provided to clinicians in English. CHADIS provides accurate scoring and interpretations completed instantly. CHADIS data is not retained on the devices where it is entered to prevent data breaches if the device is lost or stolen. It provides care coordination functionality to all secure data sharing between clinicians who are working in unrelated settings facilitated by online patient consent.

No other source provides all of the services available through CHADIS. CHADIS is available only from the manufacturer Total Child Health and is not available through resellers.

The estimated amount to be expended is for the purchase of the CHIDIS is \$39,000.00. This amount is within the expected price range for these products.
