INVITATION TO BIDDERS

Separate sealed or electronic bids for the South to Southwest Sub 46kV Pole Change-Out, **BID 2019-044WL**, will be received by the **CITY OF TUPELO** until **10:00 A.M., LOCAL TIME ON TUESDAY, THE 19TH DAY OF November, 2019** and then at said office publicly opened and read aloud. Sealed bids will be received until the designated date and time at **TUPELO CITY HALL, 71 EAST TROY STREET, TAX OFFICE, ATTENTION: KIM HANNA, TUPELO, MS 38804**. Electronic bids will be received until the date and time via electronic online submission through www.centralbidding.com.

1A pre-bid conference for this project will be held. Attendance is not mandatory. "Instructions to Bidders" contains information concerning pre-bid conference and qualifications of bidders.

The Project generally consists of the following:

Furnish labor, material, and equipment to change-out forty-seven wood poles with forty-seven steel poles in the existing 46kV/15kV Transmission/Distribution Line. Transmission conductor is **954 MCM ACSR** with **336 MCM ACSR** distribution underbuild. The transmission line can be de-energized however the distribution line must remain energized.

The Contract Documents, in printed form, may be examined at the **CITY OF TUPELO, AT CITY HALL, 71 EAST TROY STREET, TUPELO, MS 38804**.

Bids will be accepted only under the name of the Bidder to whom contract documents have been issued, and whose name appears on the official list of Planholders maintained by the City of Tupelo.

No Bidder may withdraw his bid within 45 days after the actual date of the opening thereof.

Simultaneously with his delivery of the executed contract, the Contractor shall furnish surety bonds subject to the conditions provided in the Information for Bidders.

All applicable laws, ordinances and the rules and regulations of all authorities having jurisdiction over construction of the project shall apply to the contract throughout.
