The Project generally consists of the following:

Furnishing and installation of one Natural Gas Generator Package System. Furnishing of concrete foundations, cutting and patching of existing concrete for new electrical. Furnishing and installation of Automatic Transfer Switch and all electrical connections back to the service transformer and generator. Furnishing and installation of Natural Gas connections to generator. Necessary Labor and Materials for turn-key installation.
