AMENDMENT NUMBER 4

TO

MASTER PURCHASE AGREEMENT NO. 2003MPA6052 ("MPA") BETWEEN

MISSISSIPPI DEPARTMENT OF INFORMATION TECHNOLOGY SERVICES ("ITS")
AS CONTRACTING AGENT FOR THE
AGENCIES AND INSTITUTIONS OF THE STATE OF MISSISSIPPI ("Licensee")

This Amendment Number 4 shall serve to amend the Master Purchase Agreement No. 2003MPA6052 entered into December 16, 2004 and amended on February 21, 2007, April 3, 2007, and May 21, 2008 (hereinafter referred to as "MPA") between Environmental Systems Research Institute, Inc., a California corporation having its principal place of business at 380 New York Street, Redlands, California 92373-8100 (hereinafter referred to as "ESRI") and the Mississippi Department of Information Technology Services having its principal place of business at 301 North Lamar Street, Suite 508, Jackson, Mississippi 39201 (hereinafter referred to as "ITS") as contracting agent for the agencies and institutions of the State of Mississippi (hereinafter referred to as "Licensee").

NOW THEREFORE, ITS and ESRI, by entering into this Amendment Number 4, mutually agree that the following provisions shall modify the aforementioned MPA:

Article 2, "Term of Agreement" of the MPA Terms and Conditions (E500M) section, shall be and hereby is amended so as to renew the MPA for an additional term beginning December 16, 2009 and continuing through the close of business on Friday, February 26, 2010.

Except as modified by this Amendment Number 4, the Agreement and Amendments No. 1, No. 2 and No. 3 remain unchanged and in full force and effect. The parties hereto have executed this Amendment Number 4 to be effective, valid, and binding as of the date below as executed by their duly authorized representatives.
