### Directions

AUTOSCRUBBERS - Dilute 2 to 8 ounces per gallon of scrub solution.

MANUAL DEGREASING - Dilute from 4 oz. per gallon up to full strength, depending on soil conditions. Apply to soiled area and agitate with mop, brush or cloth. Rinse thoroughly with fresh water if practical.

SOAK TANKS - Dilute 8 to 40 oz. per gallon of water, and use from room temperature to 140°F (60°C).

LAUNDRY ADDITIVE - Add 4 to 8 oz. to the break, pre-wash or wash cycle of the machine along with your regular detergent. Launder as usual. If spots are not completely removed or desired whiteness or brightness is not obtained, use pre-spotting method and launder again or increase amount added to next washing.

LAUNDRY PRESPOTTING - Apply directly to spotted areas on fabric. Agitate by rubbing fabric together or by brushing. Place in washer and launder as usual.
