
This document (hereinafter referred to as "Amendment Number 3") shall serve to amend the original Express Products List Purchase Agreement executed on October 17, 2014 and amended on June 30, 2017, and June 29, 2018 (hereinafter referred to as "EPL Agreement"), between Innovative Software, Inc. dba S.H.O.T.S. Computers, a Mississippi corporation having its principal place of business at 1901 South Adams Street, Fulton, Mississippi 38843 (hereinafter referred to as "Seller"), and the Mississippi Department of Information Technology Services having its principal place of business at 3771 Eastwood Drive, Jackson, Mississippi 39211 (hereinafter referred to as "ITS"), as contracting agent for the governmental agencies, governing authorities, and educational institutions of the State of Mississippi authorized to use the Express Products List ("EPL") (hereinafter referred to as "Purchaser"). ITS and Purchaser are sometimes collectively referred to herein as "State".

**NOW THEREFORE**, ITS and Seller, by entering into this Amendment Number 3, mutually agree that the following provisions shall modify the aforementioned EPL Agreement:

Article 1.1 under "Term of Agreement" shall be and hereby is amended so as to renew the EPL Agreement for a period of two (2) years beginning July 1, 2019, and continuing through the close of business on June 30, 2021.

All other terms and conditions of the Agreement executed on October 17, 2014 and amended on June 30, 2017, and June 29, 2018, shall remain unchanged and in full force and effect.
