GROOMS' LIMITED LIFETIME WARRANTY

1. Warranty Period:

The Limited Lifetime Warranty ("Lifetime Warranty") begins when the standard warranty expires. This Lifetime Warranty remains in effect as long as the remanufactured engine and the vehicle in which it was originally installed are owned by the original buyer of the engine covered by this Lifetime Warranty.

The Lifetime Warranty provides for a ONE TIME ONLY, replacement of the original Grooms engine. The replacement engine will be covered by the provisions of our standard warranty for 90 days from the date it is supplied by Grooms, but will not be covered by the Lifetime Warranty.

2. Warranty Coverage:

This lifetime coverage applies only to Grooms remanufactured gasoline engines that have been installed in cars, vans or pickup trucks with not more than an 8600 pounds GVWR that are used for personal, non-commercial transportation. It is not available for marine, high • performance or industrial applications.

There is no coverage available for commercial vehicles of any kind, motor homes, vehicles over 8600 pounds GVWR or engines that have been modified. Grooms shall have no obligation under this Lifetime Warranty if the buyer has purchased this policy to cover a Grooms engine installed in a vehicle that is not eligible for this coverage.



3. Warranty Provisions:

Grooms Engines warrants that should the remanufactured short-block or long-block engine supplied by Grooms fail for ANY REASON during the extended warranty period, Grooms will provide a like replacement engine, or refund an amount equal to our current selling price for the engine if it is no longer supplied by Grooms, at NO COST TO THE BUYER. The Buyer is responsible for removal of the failed engine. installation of the free replacement engine, applicable taxes and all freight costs to return the failed engine and freight to ship the free replacement engine. The Buyer MUST PROVIDE PROOF OF COVERAGE AT THE TIME OF THE CLAIM BY PRODUCING THE VALIDATED COPY OF THE NUMBERED WARRANTY CERTIFICATE showing the correct engine serial number and present proper identification, along with the current vehicle registration, in order to receive warranty consideration. This Lifetime Warranty does not cover any other repairs or replacement parts that may be associated with the change-out of the failed engine.

4. Limitations:

THIS LIFETIME WARRANTY EXCLUDES ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, PROVIDED, HOWEVER, THAT IF AND TO THE EXTENT THAT AN IMPLIED WARRANTY CANNOT BE DISCLAIMED UNDER APPLICABLE LAW, SUCH WARRANTY SHALL BE LIMITED IN DURATION TO THE DURATION OF THE COMPARABLE EXPRESS WARRANTY CONTAINED HEREIN. Fluids, filters, towing, phone expenses, loss of income, replacement transportation and any other consequential and/or incidental damages are not covered under any circumstances. The Buyer's right to a free replacement engine on these terms is the Buyer's exclusive remedy. This Lifetime Warranty is not transferable.
