Woodrow Wilson Avenue, Jackson, Mississippi. This project shall be constructed in accordance with the latest edition of the Mississippi Standard Specifications for State Aid Road and Bridge Construction.

PLANS AND PROPOSALS may be secured from Kyle Strong, LSBP Engineer for Monroe County, Mississippi, at www.cceplanroom.com. The Cost is fifty dollars (\$50.00) for plans and fifty dollars (\$50.00) for the proposal, non-refundable. Certified check or bid bond for five percent (5%) of the total bid, made payable to Monroe County and the State of Mississippi must accompany each proposal.
