Explanation of the need to be fulfilled by this item(s) and why it is the only one that can meet the specific needs of the department:

The sixty (60) seconds HIV test offers users opportunity to integrate routine, provider-initiated, opt-out HIV testing into medical screening in all healthcare settings. Further, it facilitates the testing experience for patients, enabling broader acceptance for HIV testing when offered. Equally, this test provides the chance for immediate linkage to care for HIV-infected individuals and optimizes clinical resources available. Currently, this test is the most sensitive rapid HIV test in market to provide best early detection capabilities for CLIA waiver blood based rapid HIV tests.

Name of company/individual selling the item(s) and why that source is the only possible source that can provide the required item(s):

biolytical Laboratories is the sole source manufacturer and distributor of INSTI Hiv-1.HIV-2 Kits.

<u>Estimated cost of item(s) and an explanation why the amount to be expended is considered</u> reasonable:

INSTI's standard purchase price is \$21.99/per test kit. However, Mississippi State Department of Health is receiving a reduced price of \$12.62. The controls are \$34.43 each.

Explanation of the efforts taken by the department to determine this is the only source and the efforts used to obtain the best possible price:

bioLytical Laboratories provided a current sole source document as they are the only distributor of this product in the United States. A review of the product was undertaken and it has been determined that there are no distributors who carry this product. The listed price for the test is \$21.99 and the price has been negotiated to \$12.62.

Any person or entity that objects and proposes that the commodity listed is not sole source and can be provided by another person or entity shall submit a written notice to Cynthia Brasher, Mississippi State Department of Health Purchasing Department, 570 E. The notice shall contain a detailed explanation of why the commodity is not a sole source procurement. Appropriate documentation shall also be submitted if applicable. The enclosed form (OSS) may be used if you so desire.

If after a review of the submitted notice and documents, Mississippi State Department of Health determines that the commodity in the proposed sole source request can be provided by another person or entity, then Mississippi State Department of Health will withdraw the sole source request publication from the procurement portal website and submit the procurement of the commodity to an advertised competitive bid or selection process.

If Mississippi State Department of Health determines after review that there is only one (1) source for the required commodity, the Mississippi State Department of Health will appeal to the Public Procurement Review Board. Mississippi State Department of Health will have the burden of proving that the commodity is only provided by one (1) source.

The INSTI HIV-1/HIV-2 Antibody Test is the only CLIA-waived rapid assay to use flow-through (immunofiltration) design.
