SPECIFICATIONS FOR FEEDING OF COUNTY INMATES FOR ONE (1) YEAR PERIOD BEGINNING JANUARY 1, 2019 AND ENDING DECEMBER 31, 2019

IT SHALL BE THE DUTY OF THE BIDDER TO UNDERSTAND THE SPECIFICATIONS LISTED HEREIN AND TO OBTAIN CLARIFICATION WHEN NECESSARY. IT IS NOT THE INTENT OF THE SPECIFICATIONS TO LIMIT THE BIDDING TO ANY PARTICULAR PARTY BUT RATHER TO SELECT A PRODUCT TO FILL A SPECIFIC NEED.

MINIMAL NUTRITIONAL REQUIREMENTS SHALL CONSIST OF A DIET OF WHOLESOME, NUTRITIONALLY, AND CALORICALLY ADEQUATE FOOD PREPARED UNDER SANITARY CONDITIONS. INMATES ARE TO RECEIVE A MINIMUM OF 2200 CALORIES PER DAY. MEALS SERVED MUST MEET AT LEAST TWO-THIRDS OF THE RECOMMENDED DAILY REQUIREMENTS FOR THE FOLLOWING NUTRIENTS: VITAMIN A, VITAMIN C AND VITAMIN D. EIGHT OUNCES (8 OZS.) OF FLUID MILK WILL BE SERVED DAILY TO ENSURE THAT VITAMIN D REQUIREMENTS ARE MET DAILY. HOT FOODS SHOULD BE SERVED AT A MINIMUM OF 140 DEGREES AND COLD FOODS AT A MAXIMUM OF 40 DEGREES. A VENDOR WHO DOES NOT HAVE A CURRENT AND VALID FOOD SERVICE PERMIT WILL NOT BE ALLOWED TO ENTER INTO CONTRACT TO PROVIDE MEALS TO INMATES. ALL MEALS SHALL BE DELIVERED BY THE BIDDER TO THE PERRY COUNTY JAIL IN NEW AUGUSTA, MS WITH A MAXIMUM OF THREE MEALS PER INMATE PER DAY. THE EXACT NUMBER OF MEALS SHALL BE DETERMINED BY THE SHERIFF OR HIS DESIGNEE DAILY. BREAKFAST IS TO BE DELIVERED BETWEEN THE HOURS OF 6:00 A.M. AND 8:00 A.M. DAILY. THE SECOND MEAL SHOULD BE DELIVERED BETWEEN THE HOURS OF 4:00 P.M. AND 6:00 P.M.
