# **Introduction**

The Mississippi Department of Marine Resources ("MDMR") is currently seeking a Protected Species Coordinator (PSC) contract worker for the Marine Fisheries Office.

The MDMR manages all marine life, public trust wetlands, adjacent uplands, and waterfront areas to provide for the balanced commercial, recreational, educational, and economic uses of these resources consistent with environmental concerns and social changes.

## **Scope of Work/Job Duties**

The PSC will be the point of contact for, but not limited to, the following:

- Emergency response for marine mammals and sea turtles in the event of another spill or disaster;
- Coordination with the National Oceanic and Atmosphere Association (NOAA) on relevant marine mammal and sea turtle projects in MS including, but not limited to, receiving and/or providing updates on restoration projects being conducted in MS related to marine mammals and sea turtles;
- Enhancing the understanding of in-water threats to sea turtles in MS waters (i.e., having a good comprehension of current fisheries operating in state waters, fisheries effort data, dredging programs/projects currently underway, etc.) to help inform sea turtle mortality investigation;
- Support with additional outreach efforts at piers relative to pier-based sea turtle bycatch reduction efforts; and,
- Within the State for NOAA to engage assistance with marine mammal stranding events.

Additional duties for this position include, but are not limited to, the following:

- Coordinating with NOAA's Sea Turtle Stranding and Salvage Network (STSSN), particularly the MS STSSN State Coordinator, on sea turtle stranding response needs;
- Coordinating with NOAA's Marine Mammal Health and Stranding Response Program (MMHSRP) coordinators and data diplomat for Health Map to understand data collection, inquiries, and management;
- Providing input to marine mammal and sea turtle state partnership for interactions with fisheries to provide updates to state partnership's understanding interactions with the shrimp industry, dredging, and other stressors by compiling data on stressor interaction with respective stranding data for marine mammals and sea turtles;
- Coordinating with NOAA in understanding relevant fishery and other impacts to marine mammals in state waters to ensure consistency of information;

- Participating in outreach and engaging with the fishing community within MS Sound waters to provide information on marine mammal and sea turtle interactions;
- Interacting with the shrimping community on behalf of the potential shrimp observer program;
- Coordinating with fisherman and provide oversight to the University of Southern Mississippi (USM) for data, possible observers, and industry interactions;
- Participating and coordinating with the Institute for Marine Mammal Studies, NOAA and the US Fish and Wildlife Service to train the MDMR, the MS Department of Environmental Quality, and other relevant staff to respond to marine mammal and sea turtle strandings; and,
- Performing other duties as assigned.

#### **Minimum Qualifications**

The minimum qualifications the MDMR is seeking for this position include:

- Education: A bachelor's degree from an accredited four-year college or university; and,
- **Experience:** Ten (10) years of experience related to the described job duties and marine resource management, which must have included line or functional administrative technical supervision.
- **Substitution Statement**: Related education and related experience may be substituted on an equal basis.
- Other: Must possess a valid driver's license (Mississippi residents must have a Mississippi driver's license). MDMR will verify the driver's license.

# **Compensation and Hours Worked**

This position pays \$31.00 per hour and is for 20 hours per week. The MDMR reserves the right, in its sole discretion, to increase the hourly rate of pay and/or hours per week worked in the future based upon merit, cost-of-living increases, or increases in job duties.
