Project Details

1. **Describe the commodity/service that the institution/agency is seeking to procure:**QGenda provides scheduling automation software that can reflect real-time data to show changes as they occur for complex academic medical centers involving multiple specialty providers and resident trainees with

multiple hospital and ambulatory clinic scheduling sites.

2. Explain why the commodity/service is the only one (1) that can meet the needs of the institution/agency:

The product is essential to the function and operation of the department of anesthesiology & family medicine. Anesthesia covers -30 locations both on and off campus. Generating a schedule to ensure proper coverage is extremely cumbersome without the use of this product. QGenda rules based automatic scheduling will allow us to build and publish tentative provider schedules several months out for all divisions. It then allows for easy changes for last minute or unexpected request for vacation, medical leave, administrative leave, educational duties, committee work, etc. based on the set guidelines built into the system rules. This will make the business function of building monthly provider schedules less time consuming and the reporting analytics will allow us to track clinic shifts, time-off, swaps, hospital time, etc. to show internal equity among the providers

3. Explain why the source is the only person or entity that can provide the required commodity/service:

Anesthesiology - Other companies are able to create rule-based physician schedules. However, QGenda provides a unique set of algorithms and features that no other vendor provides. These algorithms and features make QGenda uniquely qualified to address our scheduling needs. QGenda is the only HIPAA compliant automated physician scheduling program that also has native mobile applications for Apple and Android, built in compensation management capabilities, built in time tracking capabilities, and advanced reporting on the market at the moment. This is a crucial component of our requirement as our plan is to integrate Epic with QGenda. This will allow us the opportunity to create the daily assignment schedule from our 12-week block schedule. The daily assignment schedule is generated by the Anesthesiologist -in- Charge (AIC) to ensure that all scheduled cases have adequate anesthesia coverage. By linking QGenda with Epic, the AIC ensures that all assignments provide the appropriate level of care to our patients. It will also enable the AIC to optimize the assignments for non-emergent cases and meet CMS billing guidelines.

Family Medicine - We researched several industry leading scheduling vendors and spoke with family medicine academic practices across the country who use QGenda. Every academic family medicine department we spoke with was completely satisfied with the software performance and the customer service provided by QGenda. We found QGenda to be unique because it has propitiatory algorithms that can handle the complex scheduling demands necessary for a robust family medicine residency training program that includes rotations across multiple specialties and multiple clinic sites. QGenda has the ability to create complex scheduling rules that can handle the massive number of variables involved with family medicine residency training that includes multiple hospitals, clinics, nursing homes, etc. QGenda also provides unlimited training and ongoing 24 hour emergency support which is critical to our delivery of patient care.
