UMMC issues this notice in accordance with Mississippi state law, policy, and procedures for sole source procurements.

1. Where the compatibility of equipment, accessories, or replacement parts is the paramount consideration (and manufacturer is the sole supplier).
2. Where a sole supplier's item is needed for trial use or testing.
3. Where a sole supplier's item is to be required when no other item will service the needs of UMMC.

Project Details

1. Describe the commodity that the agency is seeking to procure:

The University of Mississippi Medical Center (UMMC) Department of Neurobiology & Anatomical Sciences seeks to purchase the Infinite 200 Pro M Plex microplate reader and related accessories. This equipment allows the measurement of protein concentration using kits that are absorbance, fluorescence, or luminescence based not offered in single equipment elsewhere.

2. Explain why the commodity is the only one (1) that can meet the needs of the agency:

The microplate reader is used for various measurements performed regularly in the lab from determining protein concentration in tissue samples, reading enzyme-linked immunosorbent assay (ELISA) kits, and assessing blood-brain barrier permeability. The Infinite 200 Pro M Plex is the only equipment that allows for the measurement of all the listed assays.

3. Explain why the source is the only person or entity that can provide the required commodity:

Tecan U.S. is the sole manufacturer and supplier of the Infinite 200 Pro M Plex microplate reader and related accessories. They are not available from any other distributor. See supporting letter from TECAN U.S., Attachment A.

4. Explain why the amount to be expended for the commodity is reasonable:

The estimated amount to be expended for the purchase of the Infinite 200 Pro M Plex microplate reader and related accessories is **\$24,000.00**. This amount is within the expected price range for these products.

5. Describe the efforts that the agency went through to obtain the best possible price for the commodity:

Through market intelligence, UMMC was able to negotiate best pricing for these products. All applicable discounts were explored and applied.
