Project Details

1. Describe the commodity that the agency is seeking to procure:

The University of Mississippi Medical Center (UMMC) seeks to purchase **Lumere's New Product Introduction Management Application**. This service will allow management and key performance measurement of the Value Analysis program, as well as Strategic Sourcing and Supply Chain projects, integrated with an evidence-based research library.

2. Explain why the commodity is the only one (1) that can meet the needs of the agency:

The **Lumere New Product Introduction Management Application** utilizes project management workflow linked to an extensive medical device library that allows real time enhanced evidenced-based decision making for quality outcomes.
