## **Project Details**

**1. Describe the commodity/service that the agency/institution is seeking to procure:**

SliceOmatic is a medical image analysis software that enhances researchers' ability to measure, segment and analyze multi-slice scanner data.

**2. Explain why the commodity/service is the only one (1) that can meet the needs of the agency/institution:**

The process of identifying each tissue inside an image is known as "segmentation".

**3. Explain why the source is the only person or entity that can provide the required commodity/service:**

SliceOmatic balances powerful segmentation tools with a highly interactive interface, enabling you to completely control the segmentation process.
