Lab instruments send results data to Data Innovations Instrument Manager<sup>™</sup> System, which converts the data from the instrument into an HL7 data stream that can be sent to Epic

Data Innovations is the only organization that is able to both i) develop connectivity interface drivers to its Instrument Manager<sup>™</sup> software application and ii) license, provide technical support and maintenance services (including immediate access to new updates) and perform related implementation and consulting services for the developed drivers and Instrument Manager<sup>™</sup>.
