## Project Details

**1. Describe the commodity/service that the agency/institution is seeking to procure:**

DynaCad Breast is a breast MRI post processing solution. The DynaCad solution is used to enhance the workflow of breast radiologists and improve clinical outcomes.

**2. Explain why the commodity/service is the only one (1) that can meet the needs of the agency/institution:**

DynaCad allows users to create custom hangings, one click segmentation for any suspicious area and also interventional planning. It also reduces inter reader variability and saves the radiologists a lot of time during interpretation by reducing clicks and segmentation time.

**3. Explain why the source is the only person or entity that can provide the required commodity/service:**

This support request is vendor specific for the Dynacad Breast software currently in use. This software and hardware support (as well as additional on-site training on the equipment) is only offered by Invivo.

They are not available from any other distributor. See supporting letter from **Invivo Corporation**, Attachment A.

**4. Explain why the amount to be expended for the commodity/service is reasonable:**

The estimated amount to be expended is for the purchase of the **DynaCAD Support, Maintenance & Repair**, is **\$41,250.00**. Total investment to date will be **\$41,250.00**. This amount is within the expected price range for these products.

**5. Describe the efforts that the agency/institution went through to obtain the best possible price for the commodity/service:**

Through market intelligence, UMMC was able to negotiate best pricing for these products. All applicable discounts were explored and applied.
