### **Project Details**

### **1.** Describe the commodity/service that the agency/institution is seeking to procure:

The TheraDoc platform is a real-time clinical surveillance solution that provides tools for surveillance, documentation, analytics, and compliance with regulatory requirements related to patient safety and medication management, including antimicrobial stewardship. TheraDoc provides members with a platform that enables clinicians to pro-actively identify at-risk patients with customizable tools, limiting the dependency on IT resources.

# 2. Explain why the commodity/service is the only one (1) that can meet the needs of the agency/institution:

Clinical surveillance and analytics for infection prevention and clinical pharmacy; reporting of HAI measures to NHSN for CMS measures; reporting of AUR data to NHSN.
