Project Details

- 1. Describe the commodity/service that the agency/institution is seeking to procure: Pinestar Nuclear Isotope Tracking Systems Software (Pinestar NITS) is used to document all nuclear medicine daily functions. We put patient information, radiopharmaceutical administration, all procedure names, all isotopes that are used, keeps up with radiation surveys and wipe tests, keeps up with active sealed sources, daily receipt, and disposal of radiopharmaceuticals, and can create reports. The software has a calendar that allows us to put patient information in ahead of time to document a special dose has been ordered.
