- 1. Describe the commodity/service that the agency/institution is seeking to procure: The UMMC Siemens MRI scanners have been upgraded to XA30 software. With XA30, all third parties that wish to connect to the scanner are required to do so through a Siemens Access-I router. The Access-I router is necessary for our MRI scanner to communicate with the Visualase MRI-Guided Laser Ablation system from Medtronic, which is to be used by neuro providers for tumor ablation procedures (LITT therapy). Prior to the Siemens software upgrade, this router was not necessary. The LITT therapy program is being held up until MRI can get this necessary tech.
- 2. Explain why the commodity/service is the only one (1) that can meet the needs of the agency/institution:

Access-I is required for 3rd party vendor equipment to communicate with any Siemens MRI scanner.

3. Explain why the source is the only person or entity that can provide the required commodity/service:
