Electronic cancer protocols (CAP eCP) are structured summary reports in a standardized XML format that enable the collection of cancer data elements essential for patient care and selection of treatment protocols. Pathologists are required to complete synoptic reports for certain testing protocols as part of the laboratory accreditation process. The CAP eCP product integrates with Epic to provide standard formats for these reports. They are updated periodically by CAP and implemented by Epic as data courier downloads. There are thousands of these reports and they are subject to change many times a year.

2. Explain why the commodity/service is the only one (1) that can meet the needs of the agency/institution:

The electronic cancer protocols were developed by CAP and are copyrighted and not available from any other source.

3. Explain why the source is the only person or entity that can provide the required commodity/service:

4. Explain why the amount to be expended for the commodity/service is reasonable:
