Description

USER FRIENDLY NON-ACID RESTROOM CLEANER not only helps control the hazards of cross-contamination on treated hard, nonporous, environmental surfaces but also kills many microorganisms that cause odors. Use in schools, colleges, office buildings, health care facilities, medical offices, dental offices, nursing homes and airports. This one step disinfectant cleaner is effective against a broad spectrum of bacteria, is virucidal, fungicidal, and inhibits the growth of mold and mildew, and their odors, when used as directed.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that [1] is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or [2] contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to pre-clean or decontaminate critical or semi-critical medical devices prior to sterilization or high-level disinfection.

DISINFECTION/VIRUCIDAL/FUNGICIDAL/MOLD & MILDEW DIRECTIONS: If surfaces are visibly dirty pre-clean first. Apply with a mop, sponge, cloth, or sprayer on hard, nonporous surfaces to thoroughly wet surfaces. For sprayer applications use a coarse spray device. Spray 6 - 8 inches from surface. Avoid breathing spray. Rub with a brush, sponge or cloth. Treated surfaces must remain wet for 10 minutes. Wipe dry with a clean cloth, or sponge or allow to air dry. Rinsing is not necessary on floor surfaces that are to be waxed or polished. For mold and mildew control, repeat application weekly or when growth reappears. Rinse all surfaces that come in contact with food such as countertops, appliances, tables and stovetops with potable water before reuse. This product should not be used to clean utensils, glassware and dishes.

KEEP OUT OF REACH OF CHILDREN

CAUTION. Harmful if absorbed through the skin. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling.

FIRST AID

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.
