Clarification/Answers to Questions Concerning RFx#3160001563:

In the "Minimum Bid Specs" section under #3. You state that the "vendor must provide all specimen transport requirements". Does this mean that the vendor must provide vacutainer tubes and a courier service? Or are you just asking for instructions on how to prepare the specimens for transport? Please provide the FDA approved requirements or instructions pertaining to specimen transport after specimen collection and supportive documentation, i.e., temperature requirements, maximum time to centrifuge vacutainer after collection, etc. The vendor is not expected to provide vacutainer tubes or courier service.

It appears that you are wanting to purchase the analyzer and not operate on a Reagent Rental program. Is this correct? Is it possible to get an idea of the tests and volumes you plan to run? That is correct; this is a purchase. The table below is an estimate of the tests currently run with estimated volumes. Please be mindful that the annual number of tests is only an estimate.
