AS CONTRACTING AGENT FOR THE
AGENCIES AND INSTITUTIONS OF THE STATE OF MISSISSIPPI
(ORIGINAL PROJECT NUMBER 42030)**

This document (hereinafter referred to as "Amendment Number 1") shall serve to amend the original Master Cellular Voice and Data Service and Equipment Agreement executed on June 30, 2016 (hereinafter referred to as "Master Agreement"), between Cellular South, Inc., d/b/a C Spire, a Mississippi corporation having its principal place of business at 1018 Highland Colony Parkway, Ridgeland, Mississippi 39157 (hereinafter referred to as "Contractor"), and the Mississippi Department of Information Technology Services having its principal place of business at 3771 Eastwood Drive, Jackson, Mississippi 39211 (hereinafter referred to as "ITS"), as contracting agent for the governmental agencies, educational institutions and governing authorities of the State of Mississippi (hereinafter referred to as "Customer"). ITS and Customer are sometimes collectively referred to herein as "State".

WHEREAS, the parties desire to add pricing to the Master Agreement for tethering, which is an additional service now available;

NOW THEREFORE, ITS and Contractor, by entering into this Amendment Number 1, mutually agree that the following provisions shall modify the aforementioned Master Agreement:

The parties agree that with the signing of this Amendment Number 1, the Exhibit A attached to the Master Agreement shall be and hereby is augmented by the new Exhibit A-1, which is attached to this Amendment Number 1 and incorporated herein by reference. All references in the Master Agreement to "Exhibit A" shall be and hereby are revised to be "Exhibit A and Exhibit A-1."

All other terms and conditions of the Master Agreement executed on June 30, 2016, shall remain unchanged and in full force and effect.
