How to Specify C.O.M. Upholstery

Textile designs often have intricate patterns. Not all individuals will interpret fabric direction in the same manner.

As a standard procedure, KI cuts fabrics off the roll in a horizontal fashion as shown in Diagram A at the right. By cutting in this fashion, most waste is eliminated. Our requirements for yardage in this book are based on this type of cutting. When directional or patterned fabrics are used, they often require more yardage than solid colors.

C.O.M., C.O.L. and C.O.V. Testing

KI will require for testing actual yardage to upholster one chair. The testing requirements depend on which chair you have selected on your order.

Test samples will be applied to the order and will be held for 6 months if needed. After 6 months, the sample can no longer be applied to your order. For all products to be tested, send test samples for approval to:

All C.O.M., C.O.L. and C.O.V. must be labeled with the purchase order number.

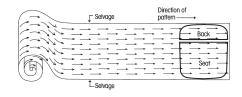
C.O.M., C.O.L. and C.O.V. Production Customer's fabrics and leathers must be approved prior to acceptance for production. Upon test approval, a 1' square sample swatch of upholstery material must accompany the order. KI assumes no responsibility for wear, defects or performance of customer's own fabrics, vinyl or leather. C.O.M., C.O.L. and C.O.V. orders are available on a deferred delivery basis.

Orders for production of C.O.M., C.O.L. and C.O.V. upholstered products are not scheduled for processing until upholstery material is received. Upon receipt, KI will provide an acknowledgement and an estimated shipping date.

A copy of this form should accompany test requests and production orders. Please fill it out completely, and, if your order has been acknowledged, provide the acknowledgement number. By providing KI with a completely filled-out copy of the form on this page, we will be able to expedite your order. We find it particularly helpful with directional or patterned upholstery material. It is critical that copies of this form accompany test quantities as well as production quantities of C.O.M.

C.O.M. must be supplied in continuous yardage.



KI recommends that leather be ordered in yardage. Leather must be usable. The outer edges cannot be calculated as square feet or yardage.

The C.O.M., C.O.L. and C.O.V. yardage requirements accompanying products in the pricing section are for 10 chairs/seats or less, 54" wide nondirectional material. On larger orders, less material is required.



KI Custom Poly Color Matching Program

Whatever you imagine, whatever you require, KI's custom color-matching program lets you pick your color. Match an organization's brand colors. Match fabrics. Match surface materials. The choice is yours.

Custom Color Matching Requirements

- Pantone Number or Color Samples. To ensure we match your color exactly, we require either a Pantone color number or two color samples (chip, swatch, or paint sample). We do request that the size be substantial enough to allow for us to retain for our internal matching process (minimum 2.5" x 3.5").
- Extended Lead Time. Using the unique combinations of specialty bases and pigments, our Custom Color Matching and Manufacturing processes do add time to your production schedule.
 - The color match process (see steps below) on average will take 2-3 weeks to produce a match sample for your review and gain your written approval to proceed. *Starting this during the quoting process is encouraged to reduce overall lead time.*
 - Orders with custom colors will typically reflect standard lead time plus 15 additional days to source the appropriate raw materials and run the custom order.
- Minimum Quantity. No additional set-up fee is incurred if the quantity (per color, product line, and order) is 100 or more. A \$500 set-up fee (per color, product line, and order) is applied if the quantity is 99 or less. You'll see a "Custom Color Set-Up Charge" note appear on your Custom Options Quote until the order is placed and quantity is determined.

Note: The Doni Seating Collection, with its two-tone color capabilities, would require a single \$500 set-up fee if one or both colors are custom. In addition, please note that reversing the inner/outer colors of Doni's two-tone standard color combinations would also be considered custom.

Custom Color Matching Process

When your purchase order is submitted, it is simply placed on hold until the color match is finalized. As soon as we receive your Pantone number or custom color samples, the process for color matching begins.

Note: If the project requires a compressed manufacturing/shipping schedule, KI encourages you to process the color match during the quotation stage. This will accelerate the purchase order release into production.

*In the event the color requested is a discontinued KI color or non-standard on the product requested, no color match is necessary (minimum quantities and extended lead time still apply). KI will use the custom options process to facilitate the quote/order.

<u>Step 2</u>. KI begins the matching process which takes 5-10 days depending upon how quickly the exact color is matched, taking into account lighting, visual and spectrographic readings as compared to the originals.

<u>Step 3.</u> We then ship the color sample chip and a letter asking for you to sign the letter and fax it back to us within 24 to 48 hours.

<u>Step 4</u>. Upon receipt of your approval signature, we remove the hold status of your order and begin production, using standard production lead times plus 15 days.





SPECIFICATIONS

Fourstar, Swivel Base

The under-seat support structure is a die-drawn 12-gauge steel plate. A 3/4" diameter steel pin is welded to the seat plate allowing the seat to swivel on a nylon bushing housed in the base. Seat structure is finished with baked-on, electrostaticallyapplied 30 degree gloss epoxy powder coating. The fixed height base constructed of a polished die-cast aluminum fourstar base and a chrome-plated steel tube column.

Tapered Steel Legs

Frames are finished in either baked-on, electrostatically-applied 30 degree gloss epoxy powder coating or bright nickelchrome plating.

Tapered Wood Leas

A seat ring is made of 1/2" diameter steel wire and attached to the seat with 14-gauge steel brackets. Inner leg wires made of 1/2" diameter steel wire complete the subframe.

Legs are turned from Beech, stained, and clear-coat finished. X-brace is made of 1/8" wire rope fastened to the wood legs with stainless steel fasteners.

Wire Tower Base

A seat ring is made of 1/2" diameter steel wire and attached to the seat with 14-gauge steel brackets. Legs are 7/16" diameter steel wire, fully gusseted with 5/16" diameter wire. All joints are welded and frames are finished in bright nickel-chrome plating.

Seat Shell and Backrest Articulation Mechanism

Backrest, seat, and shroud are injectionmolded polypropylene. The seat and backrest are joined by a pair of hidden articulation mechanisms, each consisting of a 14-gauge steel housing, twin 7-gauge levers, and steel coil springs. While maintaining a one-piece shell appearance, this mechanism allows the backrest to move through 17 degrees of movement, about an axis through the hips of the occupant.

Optional Upholstered Seat and Back

Urethane foam is attached to an injectionmolded polypropylene liner board, then upholstered using a draw-string process. Seat foam is molded nominal 1" thickness and back foam is nominal 1/2" thickness. The fasteners that attach the back pad are color-matched to the polypropylene.

Glides

The tapered steel legs are equipped with swivel glides in a bright steel finish. The wire tower base and fourstar swivel base are equipped with black nylon glides.

C.O.M. Testing and Production Requirements

Not all materials are suitable for upholstering this product. A 1 yd. x 54" sample must be submitted and approved prior to acceptance of an order. If the fabric is directional in pattern or weave, the direction must be indicated on the submitted sample, and additional yardage may be requested.

4-Leg and Caster Frame

Legs are 7/8" o.d. x 13-gauge tubular steel. A single ring of 1/2" diameter steel wire forms the cross member. All joints are welded. An optional wallsaver configuration is available. The wallsaver configuration maintains 1/2" gap between backrest and wall by locking the backrest mechanisms in the upright position.

Sled Frame

Frames are made from 3/4" o.d. x 13-gauge tubular steel. A single ring of 1/2" diameter steel wire forms the cross member. All joints are welded.

Frame Finish

Frames are finished in either baked-on electrostatically-applied 30 degree gloss epoxy powder-coating or bright nickelchrome plating.

Arms

Optional armrests are available. When equipped with arms, the support structure is a continuation of the rear leg finished to match the frame color. The armrests are injection-molded, glass-reinforced polypropylene matching the frame finish (except for chrome, hammertone, and metallic finishes which match the outer shell poly color). The steel frame tube is inserted into a socket molded into the armrest and secured with a screw.

Seat Shell and Backrest Articulation Mechanism

Backrest, seat, and shroud are injectionmolded polypropylene. The seat and backrest are joined by a pair of hidden articulation mechanisms, each consisting of a 14-gauge steel housing, twin 7-gauge levers, and steel coil springs. While maintaining a one-piece shell appearance, this mechanism allows the backrest to move through 17 degrees of movement, about an axis through the hips of the occupant.

Optional Upholstered Seat and Back

Urethane foam is attached to an injectionmolded polypropylene liner board, then upholstered using a draw-string process. Seat foam is molded nominal 1" thickness and back foam is nominal 1/2" thickness. The fasteners that attach the back pad are color-matched to the polypropylene.

Glides

The bottom ends of the leg tubes are formed to be vertical where they meet the floor. The leg tubes are capped with polyproplyene end caps matching the leg color (except chrome, hammertone, and metallic finishes which use black caps). Optional glides for the leg chairs have a bright steel surface. Optional glides for the sled base are co-extuded to provide a softer, non-skid surface to protect the floor, but do not glide. Sled base chairs are also available with black nylon (plastic), stainless steel, or non-marring (clear nylon) glides.

Casters

4-leg chairs may be ordered with casters instead of glides. Casters are double-wheel, high-impact thermoplastic available with hard or soft wheel surface, in black only.

Gangers

Optional gangers are available on armless 4-leg and sled base chairs only. Gangers are made of chrome-plated 3/16" diameter steel wire mounted to the chair with an injectionmolded nylon hub.

Stacking Vinyl Upholstered Chairs

It is recommended that stools to be stacked be covered in material other than vinyl as an impression in the seat may result. KI does not warrant the effects of stacking on stock or C.O.M. vinyl upholstery.

Seat Shell and Backrest Articulation Mechanism

Backrest, seat, and shroud are injectionmolded polypropylene. The seat and backrest are joined by a pair of hidden articulation mechanisms, each consisting of a 14-gauge steel housing, twin 7-gauge levers, and steel coil springs. The steel support tube is inserted into a socket molded into the armrest and secured with a screw. Armrests are molded from glass-reinforced polypropylene. Armrest and structure matches outer shell poly color.

Base

26" injection-molded, glass-reinforced nylon 5-blade base. A single paddle under the seat operates the height-adjusting pneumatic cylinder. Standard chair base and cylinder available in black or grey. An optional polished die-cast aluminum 5-blade base is also available

Casters

Casters are double-wheel, high-impact thermoplastic available with hard or soft wheel surface.


