NOTICE is hereby given that the Mayor and Board of Alderman of the City of Flowood, Mississippi will receive written sealed bids until the hour of **10:30 AM on Wednesday, February 15, 2017** at the office of the City Clerk of the City of Flowood, at the Flowood City Hall, 2101 Airport Road, Flowood, MS 39232, for the furnishing of all labor and materials and for the construction of that certain project designated as **“CONTRACT C – LIBERTY ROAD WATER WELL AND NORTHEAST WATER WELL”**. Drawings and Specifications being on file at the office of the City Clerk at City Hall at Flowood, Mississippi.

The project consists of construction of: **Part 1 of 2, a test hole and potable water supply well on Liberty Road near Park Drive; and, Part 2 of 2, a test hole and potable water supply well on Highway 25 Lakeland Drive near Glensview Drive, as shown on the Bid Form.** The total Contract Time will be 120 consecutive calendar days for Part 1, and 120 consecutive calendar days for Part 2, and the liquidated damages will be \$800 per consecutive calendar day thereafter, which applies to each of the completion deadlines above.
