Mississippi Gulf Coast Community College (MGCCC) will receive bids for the Pedestrian Pathway Project at Perkinston Campus, for a total project length of 0.26 miles, Federal Aid Project Number STP-0066-00(023)LPA/106898-701000 no later than 2:00 P.M., Local Time, **Thursday, the 27th day of April, 2017** at the District Office in Darby Hall, Perkinston Campus, Perkinston, Mississippi 39573. All bids so received will be publicly opened and read aloud.

The work shall consist essentially of the following items:

Construct an asphalt pedestrian pathway, which makes an approximate ¼ mile loop in the undeveloped area north east of Wire Rd. W and Myrtle St., and west of 2nd St. with pedestrian bridges, drainage improvements, connector sidewalks and lighting. All other related items of work required to complete the project as shown and specified in the Contract Documents.

The above general outline of features of the work does not in any way limit the responsibility of the contractor to perform all work and furnish all plant, labor, equipment, and materials required by the specifications and the drawings referred to therein.

The attention of bidders is directed to the Contract Provisions governing selection and employment of labor. Minimum wage rates for Federal-Aid projects have been predetermined by the Secretary of Labor and are subject to Public Law 87-581 Work Hours Act of 1962, as set forth in the Contract Provisions.

The President of the Board of Trustees of MGCCC hereby notifies all Bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged and women's business will be afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

The award of this contract will be contingent upon the Contractor satisfying the DBE/WBE requirements.

Each bid shall be accompanied by a Cashier's check, Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable Mississippi Gulf Coast Community College (MGCCC) as bid security. Bidders shall also submit a current financial statement, if requested by MGCCC. The successful bidder will be required to furnish a Performance Bond and a Payment bond each in the amount of one hundred percent (100%) of the contract amount.

The proposal and contract documents in its entirety shall be submitted in a sealed envelope and deposited with the College Architect, MGCCC, 51 Main St., Darby Hall, Suite 101, Perkinston, MS.

Work to be performed shall be in accordance with the "Mississippi State Highway Standard Specifications for Road and Bridge Construction, 2004", together with all amendments and/or special provisions and/or addenda to the standards duly approved and adopted, unless otherwise noted in these specifications.
