Project Details

1. Describe the commodity/service that the institution is seeking to procure:

The University of Mississippi Medical Center (UMMC) seeks to purchase a new QML Point-of Care data management and interface system. QML software is the middleware used to interface POCT devices to Epic. This software provides data management and reporting for the POCT section of the Clinical Lab. It also assists in meeting UMMC's accrediting agency requirements. Due to QML's open architecture, it makes it simple to add or exchange devices without any downtime. This software also allows the POCT staff to configure in real time; there is no need to call the company to assist unless it is a new interface implementation or troubleshooting for an unexpected issue. QML has the ability to lockout un-certified operators.

2. Explain why the commodity is the only one (1) that can meet the needs of the agenct/institution:

Telcor has all the instrument drivers that we currently need for the following devices: Nova Biomedical Glucose Meter, Clinitek Status Connect, Roche Coaguchek XS Plus/Pro, ACT Plus, I-Stat, GEM 4000 and the GEM OPL.

3. Explain why the source is the only person or entity that can provide the required commodity/service:

Telcor is an employee owned company which allows UMMC to grow organically and react quickly to customer request for software enhancements and functionality. Telcor is the only middleware platform not currently owned by a device or reagent company in the industry. This allows Telcor to offer us unlimited flexibility in which instrumentation we pursue.
