

PLANS AND SPECIFICATIONS are on file in the Office of the Chancery Clerk of Lincoln County, the County Engineer's office and the Office of the State Aid Engineer, 412 E. Woodrow Wilson Avenue, Jackson, Mississippi. This project shall be constructed in accordance with the latest edition of the Mississippi Standard Specifications for State Aid Road and Bridge Construction.

PLANS AND PROPOSALS may be secured from Jeff J. Dungan, County Engineer for Lincoln County, Mississippi, 120 E. Chickasaw St., Brookhaven, MS. The Cost is fifty dollars (\$50.00) for plans and fifty dollars (\$50.00) for the proposal, non-refundable

Certified check or bid bond for five percent (5%) of the total bid, made payable to Lincoln County and the State of Mississippi must accompany each proposal.

Bidders are hereby notified that any proposal accompanied by letters qualifying in any manner the condition under which the proposal is tendered will be considered an irregular bid and such proposal will not be considered in making the award.
