

ADVERTISEMENT FOR BIDS

NOTICE is hereby given that the City of Brookhaven, Mississippi, will receive written sealed bids until the hour of **2:00 pm local** time on **Thursday, January 12, 2017** at the office of the City of Brookhaven located at 301 S First Street, Brookhaven, MS 39602 (601) 833-1414 for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **Turner Street Sidewalk Improvements**.

The project includes the **construction of approximately 700 linear feet of sidewalk and related improvements**. The Contract Time will be **Seventy Five (75)** consecutive calendar days, and the liquidated damages will be **\$200** per consecutive calendar day thereafter.

State law requires a non-resident bidder to attach/include a copy of his resident state's current law pertaining to such state's treatment of non-resident contractors with their bid. Any bid submitted by a non-resident contractor which does not include the non-resident contractor's current state law shall be rejected and not considered for award.

All bids will be publicly opened and read aloud at the hour of **2:00 pm**, local time on **Thursday, January 12, 2017** at the office of the City Clerk located at **City of Brookhaven, 301 S First Street, Brookhaven, MS, 39602**. Bids will be considered by the **City of Brookhaven** at or before the next regular meeting thereof to be held within thirty (30) days of the date of receipt of bids.
