Notice is hereby given that the Mississippi Soil and Water Conservation Commission will receive written sealed bids until the hour of 9:00 o'clock A. M. local time on Monday, March 27, 2017 at which time they will be publicly opened and read. Bids will be received by hand or by mail at the offices of the Mississippi Soil and Water Conservation Commission, 680 Monroe Street, Suite B, Jackson, MS 39202 for the removal and replacement of Skuna River Watershed structure number 6 located in Chickasaw County, Mississippi.

The project includes clearing and grubbing; structure removal; protective cover; erosion control blanket; mobilization and demobilization; removal of water; excavation: earthfill; drainfill; concrete, class 3000M; 4" diameter pvc pipe schedule 40, perforated; 4" diameter pvc pipe schedule 40; 48" corrugated metal pipe – barrels; 60" corrugated metal pipe - risers; rock rip rap; geotextile material and concrete grout.

Detailed construction specifications, drawings and structure location are on file in the offices of the Mississippi Soil and Water Conservation Commission (601-354-7645). Copies of the bid packets containing specifications, drawings, instructions to bidders, bid forms and required bond forms may be obtained during regular business hours at no charge.

A pre-bid conference for all interested bidders will be held on Thursday, March 16, 2017. Interested bidders should meet at the Chickasaw County Soil and Water Conservation District Office, located at 415 Lee Horn Drive, Suite 2, Houston, Mississippi, at 10:00 a.m. that day.
