Bids may be held by the **City of Lexington** for a period not to exceed 60 days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as the **City of Lexington** may require, to reject any and all bids and to waive any informality in the bids received.
