Included with Bids, to demonstrate Bidder's qualifications to perform the Work, all Bidders shall submit with its Bid (a) written evidence establishing its experience with projects of comparable scope of work including the laying of ductile iron pipe 16" or greater in diameter and (b) references for work performed which included the laying of ductile iron pipe 16" or greater in diameter. References and experience should include no less than three (3) separate examples of experience and a minimum of two (2) references.

Minority and women's business enterprises are solicited to bid on this contract as prime contractors and are encouraged to make inquiries regarding potential subcontracting opportunities, equipment, material and/or supply needs.

This contract is funded in whole or in part by funds from the Consolidated Appropriations Act of 2014 (H.R. 3547); therefore this project must comply with the American Iron and Steel requirements of the Act.
