The North Mississippi Regional Center (NMRC) is soliciting bids for bread and bakery items for Fiscal Year 2018. Enclosed are specifications. All bids must be received in the Business Office of the NMRC on or before 2:30 p.m., Tuesday, June 13, 2017. Any bids received after the specified time will be returned unopened to the bidder. Bids must be enclosed in a sealed envelope clearly marked "Bid File #2018-02 Bread & Bakery Products." **Bids should be returned to: Jason Ivy, Director of Business Services; Administration Bldg.; North Mississippi Regional Center; 967 Regional Center Drive, Oxford, MS 38655.**

If the (NMRC) is closed for any reason, including but not limited to: acts of God, strikes, lockouts, riots, acts of war, epidemics, governmental regulations superimposed after the fact, fire, earthquakes, floods, or other natural disasters, (the "Force Majeure Events"), which closure prevents the opening of bids at the advertised date and time, all bids received shall be publicly opened and read aloud on the next business day that the NMRC shall be open and at the previously advertised time. The new date and time of the bid opening, as determined in accordance with this paragraph, shall not be advertised, and all Vendors/Contractors, upon submission of a bid proposal, shall be deemed to have knowledge of and shall have agreed to the provisions of this paragraph. Bids shall be received by the NMRC until the new date and time of the bid opening as set forth herein. The agency shall not be held responsible for the receipt of any bids for which the delivery was attempted and failed due to the closure of the NMRC as a result of a Force Majeure Event. Each Vendor/Contractor shall be required to ensure the delivery and receipt of its bid by the NMRC prior to the new date and time of the bid opening.

All line items are being awarded on an all-or-none basis. We reserve the right to reject any and all bids.

**PRODUCT SPECIFICATION:**

All bread shall be made from white enriched flour, unless otherwise specified. Enrichment shall be according to U.S. Government standards and shall meet the requirements of the State with respect to quality and wholesomeness.

**QUALITY:**

Suppliers are required to deliver bread which is "strictly fresh," that was baked not longer than 24 hours prior to delivery. Suppliers will be required to provide product code if requested to determine freshness of products.
