Regarding UMMC Sole Source Certification Number **SS9003** for **LearningSpace Enterprise Assurance Warranty**, please be advised that UMMC intends to award the purchase of the **LearningSpace Enterprise Assurance Warranty** to **CAE Healthcare, Inc.** as the sole source provider of the **LearningSpace Enterprise Assurance Warranty**.

UMMC issues this notice in accordance with Mississippi state law, policy, and procedures for sole source procurements.

Sole Source Criteria

1. Where the compatibility of equipment, accessories, or replacement parts is the paramount consideration (and manufacturer is the sole supplier).
2. Where a sole supplier's item is needed for trial use or testing.
3. Where a sole supplier's item is to be required when no other item will service the needs of UMMC.

Project Details

1. Describe the commodity that the agency/institution is seeking to procure:

The University of Mississippi Medical Center (UMMC) seeks to purchase LearningSpace, a video recording and data management system that consists of cameras, servers and proprietary software. LearningSpace is used to manage student information and video recordings of the students' clinical skills performance in a standardized, simulated clinical examination environment. We are seeking approval to continue the maintenance agreement with CAE Healthcare, which is the sole vendor of both LearningSpace and LearningSpace Warranty.

2. Explain why the commodity is the only one (1) that can meet the needs of the agency/institution:

LearningSpace is extensively used to record and provide feedback for all third-year medical students before taking their mandatory, nationwide standardized Step 2 Clinical Skills examination. It is of vital importance that the LearningSpace system – serving up to 16 clinical exam rooms with cameras, microphones, servers, and data management software – is maintained and functional. The LearningSpace warranty agreement provides labor and material for all hardware items as well as ensures that the software and the servers' operating system is patched and updated regularly. All textual data is backed up nightly, allowing for selective data restoration and preventing data loss.

3. Explain why the source is the only person or entity that can provide the required commodity/service:

While there are several simulation data and audiovisual recording and replay systems available, UMMC chose to purchase LearningSpace eight years ago. UMMC has had a maintenance agreement with the CAE Healthcare (formerly METI) since 1999. The unique feature of the LearningSpace Enterprise Assurance prorated warranty coverage is that no other vendor can provide the needed warranty and maintenance services. CAE is the sole vendor providing warranty and maintenance for CAE LearningSpace systems. See supporting letter from **CAE Healthcare, Inc.** Attachment A.

4. Explain why the amount to be expended for the commodity/service is reasonable:

The estimated amount to be expended is for the purchase of **LearningSpace Enterprise Assurance Warranty** is \$7,500.00. This amount is within the expected price range for these products.

5. Describe the efforts that the agency went through to obtain the best possible price for the commodity/service:

Through market intelligence, UMMC was able to negotiate best pricing for these products. All applicable discounts were explored and applied.
