Project Details

1. Describe the commodity/service that the institution is seeking to procure:

The University of Mississippi Medical Center (UMMC) seeks to purchase software upgrade that will allow the existing equipment to provide high speed, fully automated imaging and quantification of our researchers cells grown in 3-dimensional cultures. Service contract will provide preventive maintenance and on site repairs if needed. We will also require remote online support, phone, and email support for our users. Allows for a software upgrade after 4.1 has been purchased and installed.

2. Explain why the commodity is the only one (1) that can meet the needs of the:

The current version of the Celigo software at UMMC is 2.1.4.2. Upgrading the hardware and software setting on the Celigo at UMMC. Researchers will be able to improve speed and increase throughput of each assay by 300%.
